ORDER

1. The University, vide paper read above, had invited applications from various colleges for granting Continuation of Provisional Affiliation for the academic year 2024-25. 3. Based on the recommendation of the Scrutiny Committee and considering the fact that the allotment process for B.Pharm course for the academic year 2024-25 is about to commence soon, sanction is hereby accorded to grant Continuation of Provisional Affiliation to the 14 pharmacy colleges mentioned in table above for conducting the courses with intake mentioned against each for the academic year 2024-25, subject to the approval from the Pharmacy Council of India and ratification by the Governing Council.

4. The colleges shall strictly adhere to the following instructions:

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

iii. Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.

iv. Admission to the next academic year shall be made only after obtaining prior permission from the University.

v. The College should remit annual administration fee fixed for UG/ PG courses for the academic year 2024-25.
